(15) Description of equipment:

The YT-3400 Valve Positioner controls valve stroke, according to an input signal of 4-20 mA, which comes from a controller. The enclosure consists of a flameproof part with electronics and a pneumatic part with a pilot valve inside. YT-3450 model has a stainless steel enclosure. YT-3410 is similar construction as YT-3400 with different internal construction
